

Chemical Users Safety Awareness Training Online Course

Overview

The purpose of this training is to help to clarify the requirements around managing hazardous substances (chemicals) in the workplace to reduce the chance of injury. This course provides an in-depth understanding of workplace hazardous substances as per the Victorian Compliance Code for Hazardous Substances and Safe Work Australia Guidance. Looking into the Globally Harmonised System of classifying and labelling chemicals (GHS) it is designed to help businesses meet compliance requirements, protect worker health, and minimize chemical-related risks. You will gain knowledge of risk assessment procedures, control measures, and how to safely store and use chemicals in the workplace. While it won't make you an expert in chemicals, it will provide a foundational knowledge to help you identify workplace hazards and understand how employers and employees can meet their legal obligations in the workplace.

- Business owners
- Managers and supervisors
- Health and safety representatives (HSRs)
- Occupational health and safety (OHS) professionals
- Workers who are exposed to chemicals or use chemicals in the workplace

Objectives

By the end of this course, participants will be able to:

1. Understand the key obligations of employers relating to chemicals / hazardous substances
2. Identify chemical hazards and determine levels of risk.
3. Conduct workplace risk assessments on the chemicals present and implement chemical control measures.
4. Gain an understanding of the Globally Harmonised System (GHS), and the importance of Safety Data Sheets (SDSs).
5. Develop and apply chemical management strategies relating to usage and storage.
